If there are any special circumstances that impact your family's need for tuition assistance, or your financial situation was significantly impacted by COVID-19, please attach a letter explaining the situation and describing the impact.
3. Preferred method is to return your completed application and all supplemental documents to ChiME via email to [Finance@chimemusic.org](mailto:Finance@chimemusic.org) with the subject line Tuition Assistance Application – *Family Name*.
